Criminal Complaint

The undersigned law enforcement officer being first duly sworn, states that:

Count 1: USE OF A COMPUTER TO FACILITATE A CHILD SEX CRIME

The above-named defendant on and between February 17, 2009 and March 20, 2009, in the Village of Grafton, Ozaukee County, Wisconsin, did use a computerized communication system to communicate with an individual who the actor believed or had reason to believe had not attained the age of 16 years with intent to have sexual contact or sexual intercourse with the individual in violation of s. 948.02 (1) or (2), contrary to sec. 948.075(1r), 939.50(3)(c) Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute Section 939.617, upon conviction the Court shall impose a bifurcated sentence including a term of initial confinement for at least five years. The Court may impose a sentence less than five years or place the person on probation upon a finding on the record that the Court finds the lesser sentence is in the best interests of the community and the public will not be harmed.

PROBABLE CAUSE:

Complainant alleges that DCI Agent Vandenberg through the use of a computer received a computer communication from a person later identifying himself as David Hittle from a chat room instant message where he communicates with DCI Agent Vandenberg at which time David Hittle believes he is talking to a 15 year old female. During the course of several different communications, David Hittle communicates to Agent Vandenberg who he believes is a 15 year old girl named "Pam" on how he wants to have sexual intercourse with her and

other sexual contacts. On at least two separate communications David Hittle through the use of a web cam sends to "Pam" simultaneous photographic images of David Hittle masturbating to the point of ejaculation. He further attempts to make arrangements to meet up with "Pam" so he can have intercourse with her. DCI Agent Hoell went to David Hittle's residence in the Village of Grafton, Ozaukee County, State of Wisconsin, at which time Mr. Hittle admits he did masturbate in front of the web cam for a 15 year old girl and that he did communicate with a 15 year old girl to have sex with her, the 15 year old girl he knew as "Pam." He then wrote a letter of apology to the 15 year old girl's family as well as their 15 year old daughter "Pam."

Complainant further alleges that all the above stated events occurred in the County of Ozaukee, State of Wisconsin.

Based on the foregoing, the complainant believes this complaint to be true and correct.
