POSSESSION OF CHILD PORNOGRAPHY

Count 3 - On or about the 7th day of July, 2011 in the Village of Plover, City of Stevens Point, Portage County, Wisconsin, the defendant did knowingly possess a photograph, motion picture, video tape or other recording of a child engaged in sexually explicit conduct, knowing the character and content of the sexually explicit conduct in the material and knowing or reasonably should have known that the child engaged in sexually explicit conduct had not attained the age of 18 years, to wit: a video recording described as "Pedoland Frifam Viola 4-Foxy-Stop dont stop", contrary to sec. 948.12(1m) Wis. Stats., a Class D Felony, punishable by a fine not to exceed \$100,000 or imprisonment not to exceed 25 years, or both.

POSSESSION OF CHILD PORNOGRAPHY

Count 4 - On or about the 7th day of July, 2011 in the Village of Plover, Portage County, Wisconsin, the defendant did knowingly possess a photograph, motion picture, video tape or other recording of a child engaged in sexually explicit conduct, knowing the character and content of the sexually explicit conduct in the material and knowing or reasonably should have known that the child engaged in sexually explicit conduct had not attained the age of 18 years, to wit: a video recording described as "Pedoland - 5YO And 12YO 07 Childporn 7YO Suck Man", contrary to sec. 948.12(1m) Wis. Stats., a Class D Felony, punishable by a fine not to exceed \$100,000 or imprisonment not to exceed 25 years, or both

This is against the peace and dignity of the State of Wisconsin. Your complainant asks that the defendant be dealt with according to law.

The probable cause for complainant's allegation of said offense is:

Your complainant is a Detective with the Stevens Point Police Department. Your complainant's information is based on the records and files of that department and the records of the Wisconsin Department of Justice, Division of Criminal Investigations. Your complainant has relied on these records and files in the past and has found them to be both truthful and reliable. Those records and files indicate the following information:

Special Agent Loreen Glaman, whom your complainant knows to be truthful and reliable based on past professional contacts,

reports that on July 7, 2011, a search warrant was executed at the premises of 2011 Windsor Court, Apt. #2 in the Village of Plover, Portage County, Wisconsin, which was the residence of Joshua Steward. As a result of that search warrant, three computers, hard-drives, miscellaneous memory cards, flash drives and computer storage devices were recovered.

Glaman reports that she and Special Agent David P. Forsythe of the Wisconsin Department of Justice/DCI interviewed Steward who stated he has seen child pornography on his computer and he wouldn't be surprised if law enforcement found child pornography on his computer. Steward stated he did not intentionally download child pornography and doesn't know how it got on his computer. Steward believes he may have three or four child pornography files on his computer currently. Steward reports he installed one of the Peer to Peer file sharing programs on his computer approximately two months ago and thinks it was Frostwire. Steward indicated he lived at the residence alone and everything in the apartment belongs to him, including the computers.

Glaman reports that she examined CD-R preview disc provided to her by DCI Analyst Toby Carlson. The disc was prepared by Analyst Carlson during the execution of a search warrant on July 7, 2011 at the residence of Joshua Steward, DOB: 04/09/1985, located at 2011 Windsor Court, Apt. #2, Plover, Portage County, Wisconsin and the disc contained 13 files. The files were from a hard drive removed from a SopranoRS tower computer located in the apartment. Glaman described the files she observed as follows:

Video #1

This video is approximately 3:33, and begins with a young girl lying on her back on a bed. She is wearing an aqua top with yellow piping, and blue shorts pulled down around her ankles. Her legs are raised in the air, exposing her naked vagina. She has her fingers on her vaginal area and says, "Daddy, you can do whatever you want." The girl has no pubic hair, consistent with a child under the age of eight years old. An adult male puts his fingers on her vaginal area and separates the lips of her vagina. He places his finger inside of her and states, "It's so tight. I'm touching your cervix right now." The scene changes and the same girl is now naked from the waist down wearing a white T-shirt. An adult male has his penis inside the girl's vagina. He says several things to her, including "pull your pussy open".

The scene changes again and a little girl is lying between the legs of an adult male. She is wearing a white T-shirt with a rainbow on it. She has her mouth on his penis. The male says to her "all the way down your throat." The scene changes and the girl is lying naked on a bed as an adult male ejaculates on her face. She appears to be the same girl; she has no breast development and is small in stature, consistent with a child under 8 years old.

Video #3

This video is :50 in length and begins with a girl lying on her back on a bed with white sheets. She is naked, has no pubic hair and no breast development, consistent with a child under 8 years old. An adult female is licking the girl's vagina as she holds the girl's legs apart. She licks the child's belly and legs, then licks her vagina as the camera zooms in on the naked vagina.

Video #7

This video is 3:00 in length and begins with a girl wearing pink pants and a pink top with the cartoon character "Dora" on it. The girl lies back on a bed and pulls down her pants to her ankles. An unknown male can be heard in the background and he places a sex toy on her vagina. The girl takes the toy and rubs it on her vagina and then hands it back to the man. She turns

over and kneels on the bed, pushing her naked buttocks into the air. The man puts the sex toy on the girl's buttocks and anus area. The girl has no vaginal hair and is small in stature, consistent with a child under 11 years old.

Video #9

This video is 1:39 in length and is part of the known "Vicky" child pornography series. It begins with a clothed girl. She begins a strip-tease, removing her top, skirt, panties and training bra. When she is only wearing black "thigh-high" socks, she kneels down on the floor and unzips an adult male's pants, exposing his erect penis. She sucks on his penis and the video ends. The girl has no public hair and no breast development, consistent with a child under 12 years old.

Video #13

This video is 1:05 in length and consists of an adult male touching the vaginal area of a female child who is lying naked in a bed under a gray blanket. The man moves the blanket revealing a child who is small in stature, has no pubic hair and no breast development, consistent with a child under 8 years old. The male places his mouth on the girl's vagina. He has dark facial hair. The file continues with the male digitally

touching her vagina and rubbing his penis on her vagina. The male ejaculates on her vagina.


